PROMOTION RULES "MOICO 60+"

- 1. These Regulations define the conditions under which you can take advantage of the "Moico 60+" promotion (hereinafter: the Promotion).
- 2. Internet Union S.A. organises the promotion with its registered office in Wrocław at ul. Złotnicka 28, registered in the register of entrepreneurs of the National Court Register kept by the District Court for Wrocław Fabryczna VI Commercial Division of the National Court Register under the number KRS 0000388937, NIP 8943024998, Regon: 021547015 (hereinafter: Organiser).
- 3. The promotion lasts from January 1, 2021, until cancelled by the Organiser (promotion period).
- 4. The promotion applies to the KISS Alice service and addresses people over 60.
- 5. The promotion is addressed to persons not Internet Union S.A. subscribers during the promotion period (hereinafter: Promotion participant).
- 6. The offer on the promotion terms applies only to selected locations to which the Organizer's service reaches and in which the Organizer can connect the service covered by the promotion. As part of the promotion, the Organizer will not use telecommunications equipment.
- 7. The condition for taking advantage of the promotion by the participant is:
- a) accepting the terms of these Regulations;
- b) conclusion with Internet Union S.A. during the promotion period of the contract for the provision of telecommunications services as part of the KISS ALICE package, for an indefinite period
- c) the age of 60 of the promotion participant, where the age of the promotion participant is verified by the application of the PESEL number and presenting an identity document with the PESEL number at the conclusion of the contract, and in the case of signing the contract during the installation of the telecommunications service, the participant of the promotion who intends to take advantage of the promotion should present it an identity document with a PESEL number available for inspection by the Organiser's representative.
- 8. The promotion consists of the fact that the promotion participant may use the KISS Alice package service in the promotional price conditions, i.e. in a monthly subscription of PLN 69 instead of the standard monthly subscription amount for this package, PLN 99.
- 9. The promotion cannot be combined with other such promotions.
- 10. The Regulations are available on the website www.moico.pl and at the seat of the Promotion Organizer.
- 11. The participants' personal data administrator in this promotion is Internet Union S.A., based in Wroclaw at ul. Złotnicka 28, registered in the Register of Entrepreneurs of the National Court Register, run and kept by the District Court for Wrocław Fabryczna, 6th Commercial Division of the National Court Register, under the number KRS 0000388937, NIP 8943024998, Regon 021547015.
- a) Personal data of promotion participants will be processed only to provide participants with opportunities to implement the promotion.
- b) In connection with the promotion, the participant's data enabling verification of the participant in the system will be processed by the Administrator to confirm the status of the promotion participant, i.e. the following personal data: participant's PESEL number, name and surname, address, telephone number and e-mail address of the participant in the promotion.
- c) The promotion participant has the right to access and correct their personal data. This right can be done by sending an appropriate application to the following address: enjoy@moico.pl.
- d) Providing personal data is voluntary but necessary to take advantage of the promotion.
- e) The administrator may use the collected data for marketing purposes with the separate consent of the participant.
- f) Personal data may be disclosed only to employees or associates of the Data Administrator and entities providing support based on outsourced services and by concluded entrustment agreements. In such a case, personal data is transferred only to duly authorised persons obliged to maintain secrecy only for the purpose specified in point a) above, to whom data processing was entrusted in writing personal data and who is responsible for violation of the processing rules.

- g) Personal data of the promotion participant will be processed for the time necessary to properly implement the promotion and contracts for providing telecommunications services.
- h) The promotion participant has the right to request access to personal data concerning him, the right to rectify them, deletion or limitation of processing, the right to object to processing and the right to data portability. At any time, the participant has the right to object to the processing data processed for the purpose and based on the above. The administrator will stop processing the participant's data for these purposes unless he can demonstrate that there are valid, legitimate grounds that are superior to the interests, rights and freedoms of the Participant or the Participant's data will be necessary to carry out the promotion or possible determination or pursuit of claims.
- i) the participant may withdraw their consent at any time. Withdrawal of consent does not affect the lawfulness of the processing carried out based on the consent expressed by the participant before its withdrawal.
- j) the participant has the right to complain to the supervisory authority.
- k) by concluding a contract for the provision of telecommunications services under this promotion, The participant declares that he accepts these Regulations and consents to the processing of his data by the Organizer personal data within the meaning of generally applicable regulations to ensure the correct use of from promotions and telecommunications services.
- 12. The Organizer informs that the Promotion Participant, if he has concluded a contract for the provision of telecommunications services on conditions of the Promotion as a consumer, off-premises or at a distance, has the right to withdraw from the agreement within 14 days from the date of conclusion of the agreement. The deadline will be met if the Participant sends the benefit withdrawal before the expiry of 14 days. In the event of withdrawal from the contract, it is considered void. In this situation, the Participant must return the devices if they received them in connection with the concluded contract. Promotion participants make the return at their own expense and no later than within 14 days from the contract's withdrawal date to the following address: Kościuszki 117/2u Wrocław. - 13. These Regulations come into force on January 1, 2021.
